#### DESCRIPTION

Sikament® RB 890 is formulated from

synthetic polymers specially designed to impart rheoplastic qualities to concrete.

A rheoplastic concrete is a fluid concrete with a slump of at least 200mm, easily flowing, but at the same time free from segregation and having the same w/c ratio as that of a low slump concrete (25mm) without admixture.

Recommended dosage	Optimum dosage of Sikament <sup>®</sup> RB 890 should be determined in trial mixes. As a guide, the following dosages are recommended as a starting point for any trial: in normal concrete, a dosage of between 0.8-2ltr/100kg of ce- ment; in high performance microsilica concrete, a dosage of between 1.5- 3ltr/100kg of cement. Dependent upon mix requirement, it is possible to use a higher dosage of Sikament <sup>®</sup> RB 890 without causing any adverse ef- fects upon the concrete. Dispensing	Sikament <sup>®</sup> RB 890 is a ready-to-use liquid, which is dispensed into the con- crete together with mixing water. The plasticising effect, or water reduc- tion, is higher if the admixture is added to the concrete after 50-70% of the mixing water hasbeen added. The addition of Sikament <sup>®</sup> RB 890 to dry ag- gregate or cement is not recommended. Automatic dispensers are available.
Compatibility	Sikament <sup>®</sup> RB 890 is compatible with all cements and most air-entraining agents meeting the ASTM standards. The addition of Sikament <sup>®</sup> RB 890 and SikaControl <sup>®</sup> -111 AER (air-entraining agent) to concrete is recommended where it is required to withstand freezing and thawing cycles.
