APPLICATION INFORMATION

Recommended dosage	Optimum dosage of Sikament® RB 3045 should be determined in trial mixes. As a guide, the following dosages are recommended as a starting point for any trial: In normal concrete, a dosage of between 0.6 3.0 ltr/100kg of cement. Dependent upon mix requirement, it is possible to use a higher dosage of Sikament® RB 3045 without causing any adverse effects upon the concrete.
Dispensing	Sikament® RB 3045 is a readytouse liquid which is dispensed into the concrete together with the mixing water. The plasticising effect and water reduction are higher if the admixture is added to the concrete after 50 to 70% of the mixing water has been added. The addition of Sikament® RB 3045 to dry aggregate or cement is not recommended. Automatic dispensers are available. Sikament® RB 3045 ensures that rheoplastic concrete remains workable in excess 2 hours at +20°C.
Compatibility	Sikament® RB 3045 is compatible with all cements and most airentraining agents meeting the ASTM standards. The addition of Sikament® RB 3045 and SikaControl®-111 AER (airentraining agent) to concrete is recommended where it is required to withstand freezing and thawing cycles.
