## **APPLICATION INSTRUCTIONS**

#### SUBSTRATE QUALITY / PRE-TREATMENT

Concrete surface must be clean, sound, level and uncontaminated by oil or grease. Remove cement laitance, formwork traces and loosely adhering particles by sand blasting or high pressure water jetting. Absorbent substrates must be pre-wetted to saturated surface dry (SSD) conditions.

#### APPLICATION

Use 5- 6 litres water to 30 kg powder Mix well with a hand trowel. For large volume mixing, a slow speed drill is recommended. Do not add additional water in case of delay, just remix the mortar
